Members were informed of Race to the Top-Early Learning Challenge grant application submission on October 19th, and provided with the logic models that highlight each section of application. The group was informed that while Family Involvement was not a discrete section of the application, family engagement was woven throughout the application relating to Early Learning Standards, Quality Rating and Improvement Systems (QRIS) and Health Standards. Zero to Three Home Visitation Systems Request for Application

Elaine presented an overview of the Request for Applications (RFA) from Zero to Three with an opportunity for states to participate in a policy action team meeting on integrating quality home visiting services in state early childhood systems."

A quick overview was provided of the components of the application—
Background, the State Policy Action Team Meeting, Eligible Applicants, Application Process and Selection Criteria. Copies of the RFA were distributed.

The group was updated on an initial discussion on the RFA that took place with a subset of the workgroup to frame the assets of Connecticut relating to systems building and home visitation.

Mary Kate Lowndes, of the Commission on Children, will be the primary writer for the Zero to Three Application.

The response from states is expected to be approximately five pages; consequently, will be very dense.

The subgroup identified the following assets as being unique to CT and were recommended as elements for the application,

- The recent 11-181 Legislation, calling for a coordinated ECE system.
- The DCF infant/toddler Foster Care System.
- Proven infant/toddler mental health home visitation models (e.g. Child First).
- Legislative (Black/Puerto Rican

Help Me Grow, as implemented through 2.1.1., is a valuable component. Budgetary challenges compel us to rethink state priorities, as evidenced by the Governor committing to increasing access to early care and education experiences and DCF repurposing resources to focus more on prevention and early intervention. The state lens on child development has expanded to include health and home visitation. Streamlining resources is imperative to promote increased case coordination. Clear communication channels need to be established to ensure families

are aware of the existing resources.

- Coordination improvements are needed in multiple sectors, not just ECE.
- The conversation should be a balanced one of assets and gaps.
- Confirmation that there are plenty of families and limited funding.
- Coordination and integration hinge on RELATIONSHIP building; it is about a shift in culture. "Culture eats strategy for breakfast,"-Doug Edwards.
- Coordination is about realizing the unique expertise of stakeholders.
- Reinforce the bottom up, community approach.
- A true system performs universal assessment of families' needs and triages based upon those needs, (e.g. an assessment of needs at child birth).
- Consideration must be given to how the system addresses access of micro-populations to needed services, (e.g. children with special healthcare needs).
- Families have multiple needs; a review of Entitlements is necessary.
