Learning Table Overview

State teams will engage in a structured dialogue with national experts and other state teams to assess their current state technical assistance system on four levels (early learning programs, technical assistance professionals, supervisor/sponsoring agencies, and finally the state level). Teams will be supported to create an implementation plan to establish a more effective and efficient technical assistance system that can promote high quality early care and learning programs and achieve better outcomes for children.

Format

This learning table series, from February to May 2013, will include five two-hour, live, interactive web-based sessions and one in-person meeting on February 26-27, 2013. Participants will also have access to an electronic collection of resources related to the Learning Tables' topics. Each web-based session will focus on an individual topic within the broad frame of Effective Technical Assistance and will be designed to be highly interactive with discussion and sharing among participating states. State teams may also receive follow-up technical assistance after each session in order to more directly address individual state needs. States will be asked to select up to eight team members for participation in the learning table and to plan to meet between sessions to discuss homework assignments and application of the information to their state context.

The Learning Table will be facilitated by Billie Young (National Association for the Education of Young Children), Sheila Smith (National Center for Children in Poverty), and Debi Mathias (QRIS National Learning Network/BUILD) with other national experts. The National Center on Child Care Professional Development Systems and Workforce Initiatives & the National Center on Child Care Quality Improvement are supporting the Learning Table as resource persons.

In-Person Meeting

The second Learning Table session will be an in-person meeting on February 26-27, 2013. All other sessions will be live, on-line. For the inperson meeting, BUILD will fund airfare, lodging and some meals for TWO participants from each state. If the state would like to send additional people, they will be responsible for their expenses. Upon notification of your acceptance in the Learning Table, you will be asked to submit the names of the two team members that you would like BUILD to sponsor for participation at the inperson meeting.

Team Structure

For the web-based sessions, states may • include approximately six-eight team members; identifying this team will be part of the application. When creating the team, consider members empowered to engage in analysis of current cross-sector state technical assistance, analyze emerging best practice and innovation in technical assistance and, based on the learning table work, to subsequently recommend and/or implement systems modifications and changes within the state technical assistance system. Team members to consider should include (but not be limited to) leaders who are • Teams should specify who will be involved in:

- QRIS administration;
- planning and implementing your state's professional development system;
- · your state's training and technical assistance system.

You might also consider including funders, a representative of an early learning program and cross-sector program representatives.

Commitment

- Team members are asked to participate in all web-based sessions in order to make the most of this opportunity. Team members participating in the in-person session would attend both that meeting and all web-based sessions.
- Team members should plan to convene by phone or in-person meetings between sessions to work together on "homework" assignments and to discuss how to apply what they are learning to their own state technical assistance efforts.

Learning Table Schedule and Topics

Laying the Foundation for Effective State Technical Assistance Systems

Date: Thursday, February 7, 2013 2:00-4:00pm EST on-line

Participants will:

- Receive overview of topical learning table sessions, meeting premises, and the fourlevels of system-building.
- 2. Examine key child and family outcomes that technical assistance systems should support (drawing from current research on what competencies/capacities children need to succeed) and implications of targeting these outcomes for each level of the system.
- Explore key findings from research on technical assistance (defined as a component of professional development) and implications for each level of the system.
- 4. Review historical development of national and state technical assistance initiatives.

Mapping Your State's TA System, Setting Goals and Tapping into New Resources

Participants will:

- Make connections with Learning Table state leaders and identify peer resources.
- Share the initial state TA map and gain ideas about deepening the technical assistance map across settings, sectors, and funding streams; consider access to and quality of TA and implications for programs, technical assistance providers, intermediaries and systems.
- Identify indicators of an effective, integrated, cross sector technical assistance system, through consideration of terminology, governance, finance and sustainability.
- 4. Begin the self-assessment, Policy Advocacy Tool, and establish priorities for continuing the work with the State team.
- Learn how to use the Technical Assistance Planning Template and follow up with your state teams.
